TCCW Meeting Minutes

April 2, 2015

President Linda Borror called the meeting to order at 12:10 p.m. Flag salute, Creed and introductions followed.

Approval of Minutes: Cathy Tobin made a motion that the minutes of the February meeting be approved as mailed, motion seconded by Darci Richeson, motion carried.

Committee Reports: Tammy Chrisler, **Legislative** reported on GRAP (Grazing Restriction Action Plan), CCA was having a ranch tour in Shasta County for involved committee members. USDA Dietary Guidelines, comment period extended until May 8, 2015. Pem Lester, **Sunshine**, absent (sympathy card sent to Rhyanne Skinner); Vicky Dawley, **Scholarship**, absent, report read. **Publicity**, comments by Linda Borror that both Jean Barton and Anne Read had news articles which had been printed. **Membership**, Shirley Davis, reported Membership Directory for Ann Bugenig should be corrected to Duck Trail Ct., new membership information must be turned in to Shirley immediately.

• Treasurer's Report: Renee Ewing made the report. A motion was made to approve the Treasurer's Report, seconded and carried. A question of a donation to the Chico Young Farmer's 5K Run was asked. Renee Ewing will check to see if it is a budgeted item.

Correspondence: Thank you notes from students in SERRF programs from Lassen View and Corning schools were read. **OLD BUSINESS:**

- Donation to Farm Bureau Kari Dodd reported that the carpets had been cleaned throughout the building. CattleWomen felt that they would like to pay for the Conference Room carpet cleaning. After discussion, Tammy Chrisler made a motion to pay \$201 for the cleaning of the Conference Room carpet, motion seconded by Beth Chaney, motion carried.
- CattleWomen Vests Dee Hill reported she has 3 more vests to collect on and she will then turn in the money. A total of 53 vests have been ordered. Kelly Mouton said she wore a vest at the California CattleWomen's Meeting in March and they were well received. Dee hopes to have them completed in time to wear at the Mixer on April 16. The project has created a lot of denim "scraps" which would be good for a quilting project and is available to whoever would like it.

- CattleWomen reimbursed beef purchased in the amount of \$50; \$25 to Barton and \$25 to Tobin. Irene Fuller reported that 2Bud's BBQ had donated two sliced tri-tips to the event.
- Trail Ride Charlene Priest, Ride Chair, displayed the quilt donated by Margie Kutz for the raffle. Charlene asked for more raffle items from members. Trail Ride is May 9, cost is \$40, entry forms are on the website and posters are up.
- Cattlemen's Field Day Beth Chaney reported that Beef Ambassadors and FFA kids helped. Not a lot of kids participated, plenty of prizes awarded. Kelly Mouton purchased the prizes and asked if CattleWomen were to reimburse her or Cattlemen. She further stated she could use the left over prizes for some of her other kids activities involving beef education. Cathy Tobin made a motion, seconded by Charlene Priest for CattleWomen to reimburse Kelly Mouton for her expense. Motion carried. [Expense was roughly \$100].
